### **NOTE:**

- The Number of posts & category mentioned above may vary or likely to change.
- The eligible candidates in the earlier notification No.NIMH/PER(6)/RECT/ADVT-1/2022-23 dated: 25.07.2022 for the post of Stenographer Grade – II and Electrician will be considered for the present notification against the said posts and are eligible for participation in the recruitment process.
- The candidates who are shortlisted in the eligible test will be required to appear in the Skill Test for Stenography. It is mandatory to write the dictation in shorthand (Steno Language), failing which the candidature will be disqualified.
- ANY CORRIGENDUM / ADDENDUM / MODIFICATION, ETC. IN THE NOTIFICATION WILL BE MADE AVAILABLE ON THE INSTITUTE'S WEBSITE (ONLY). NO FURTHER PRESS ADVERTISEMENT / NOTIFICATION WILL BE PUBLISHED IN THIS REGARD.
- All other category candidates can provisionally apply against post earmarked for EWS category with the following conditions:
  - That their candidature will be considered only if EWS applicants are not available.
  - That their candidature will be as UR candidates only, which means, there shall be no relaxations which are otherwise permitted under their specific categories.
- 4% Reservation for PwBD Candidates as per Government of India Reservation Policy from against among the above Notified Posts.
